RESOLUTION TO ADOPT THE AMENDED THE FEE SCHEDULE FOR THE TOWN OF DAY

WHEREAS, the Town of Day issues a variety of permits and provides services for which a fee is required to be paid under the Town of Day Code of Ordinances; and

WHEREAS, from time to time the Town Board approves a Fee Schedule to establish the costs to be collected for the issuance of such permits and the performance of such services; and

WHEREAS, in accordance with the requirements of Wis Stat. § 66.0628, The Town Board periodically reviews the fees imposed by the Town to ensure that they bear a "reasonable relationship" to the Town's reasonable direct costs to provide the permit or service; and

WHEREAS, The Town Board has reviewed the current Fee Schedule and has proposed certain specific revisions to ensure that the said Fee Schedule reflects the Town costs of providing the permits and services provided for therein.

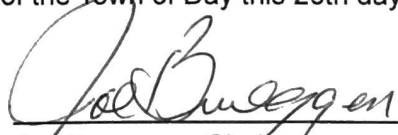
NOW, THEREFORE, the Town Board of the Town of Day, Marathon County, Wisconsin, do ordain as follows:

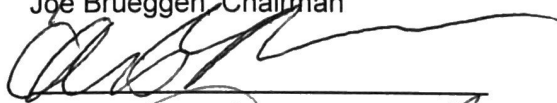
SECTION 1. IT IS HEREBY RESOLVED that the Fee Schedule dated January 20, 2026, attached hereto and incorporated by reference is hereby ADOPTED for all purposes.

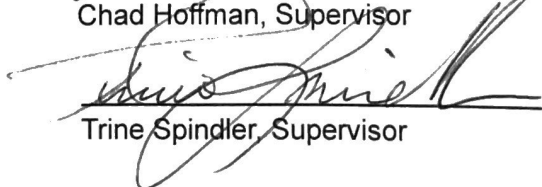

SECTION 3: EFFECTIVE DATE. This Resolution shall take effect January 20, 2026.

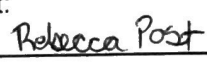

Effective January 20, 2026

Fees for permits shall be paid to the Town prior to the issuance of any permit.

Failure to obtain a permit prior to commencing work will result in an additional \$100.00 fee or double the permit fee, whichever is more.

A failed inspection may require a reinspection fee of \$50.00.
