

RESOLUTION NO. 2026-06

RESOLUTION ESTABLISHING A SPECIAL 15-TON GROSS WEIGHT LIMIT ON THE SOUTH END OF VEERLAND ROAD IN THE TWIN CULVERT AREA UNDER AUTHORITY OF WIS. STATS. § 348.17

WHEREAS, the Town of Day, Marathon County, Wisconsin, is responsible for the maintenance and protection of town roads; and

WHEREAS, Veerland Road within the Town of Day is scheduled for construction and related improvements during the 2026–2027 project period; and

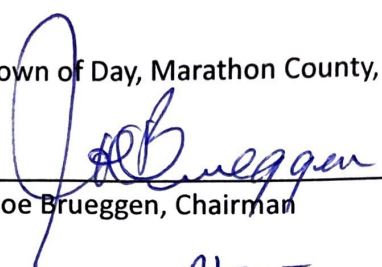
WHEREAS, Wisconsin Statutes Chapter 348 governs vehicle size, weight, and load, and § 348.17 specifically authorizes state or local authorities to impose special or seasonal weight limitations on particular highways, highway structures, or portions of highways when signs have been erected giving notice of such weight limitations; and

WHEREAS, the Town Board of the Town of Day finds that a special weight limitation is necessary and appropriate to protect the twin culvert area on the south end of Veerland Road, the public investment therein, and public safety during the project period.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Day, Marathon County, Wisconsin, that:

1. **Special weight limit established.** A special **15-ton gross vehicle weight limit** is hereby established on the twin culvert area on the south end of Veerland Road within the Town of Day.
2. **Effective dates.** This special weight limit shall be effective beginning **September 1, 2026**, and shall remain in effect **until completion of the Veerland Road culvert project in 2027** or until modified or rescinded by subsequent action of the Town Board.
3. **Authority and enforcement.**
 - This special weight limitation is imposed pursuant to the authority granted in **Wis. Stats. § 348.17**, together with all other applicable provisions of Wisconsin.
 - No person shall operate a vehicle in violation of this special weight limitation when signs have been erected giving notice of the limitation, except as may be expressly authorized under a valid permit or other authorization consistent with Wisconsin.
4. **Signage and notices.** The Town Chair, or their designee is directed and authorized to cause appropriate signs to be posted on Veerland Road and at such other locations as may be necessary to give notice of this special weight limitation, in accordance with Wis. Stats. § 349.16(2) and related provisions.
5. **Permits and exceptions.** Any person seeking permission to exceed the posted special weight limit on Veerland Road must obtain prior written approval or permit from the Town of Day, if and to the extent permitted under Wisconsin law.
6. **Publication/posting.** This resolution shall take effect upon its adoption and posting or publication as required by law.

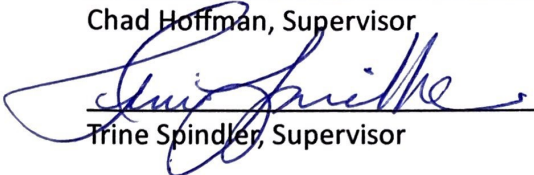
